 Administer influenza vaccine annually to ALL residents, new admissions, staff, physicians, and volunteers who work in the facility Please refer to <u>BCCDC Immunization Manual Biological Products</u> webpage 			
• Keep a record of the immunization status of the residents/staff/physicians/volunteers that is easily accessible by the nursing/medical staff at all times.			
 b) Pneumococcal Administer pneumococcal vaccine to all residents This vaccine is given once and can be given at any time during the year. 			



 Note: a once only re-vaccination should be offered 5 years after initial immunization to those with certain medical risk factors. Please refer to <u>BCCDC Immunization Manual</u> Pneumococcal Polysaccharide 			
 If vaccine history is not available, immunize with pneumococcal vaccine 			
6. Review stock of PPE supplies required for the facility and order additional supplies as			
necessary.			
 Owned and operated sites to order through ePro 			
Contracted/private sites through their regular supply process			
7. Review supplies required for residents on precautions,			
• Ensure sites have closed PPE carts, over bed tables, signage printed and laminated or on wipe able paper, in room garbage/ linen/personal laundry hampers, utility tables.			
Ensure the supplies are on site and accessible.			
Develop a process for ensuring supplies available and reorder as necessary.			-

8. Ensure you have up to date fit tested staff.			
• If you have symptomatic or positive residents that are on CPAP or BiPAP. Annual fit testing is required.			
• Identify residents on CPAP and BIPAP and have a care plan in place in the event the resident developed a viral respiratory illness during VRI season.			
• Consider having a plan for residents with CPAP and BiPAP.
